

A BILL TO CREATE AN ORDINANCE ENTITLED:

“AN ORDINANCE VACATING A PORTION OF NORTH ROLLINS STREET ADJACENT TO THE WEST LINE OF BLOCK THREE (3) OF THE ORIGINAL TOWN, NOW CITY OF CENTRALIA, MISSOURI.”

WHEREAS, there was submitted to the City of Centralia, Missouri, Planning and Zoning Commission in accordance with Section 2-81(J) of the Centralia City Code, a proposal to close, discontinue and vacate the east twenty feet of the street right-of-way of North Rollins Street adjacent to and west of the west line of Lots 9 through 16 of Block 3 of the Original Town, now City of Centralia, Missouri; and

WHEREAS, during its meeting of November 17, 2011, the City of Centralia, Missouri, Planning and Zoning Commission approved the proposal to close, discontinue and vacate the east twenty feet of the street right-of-way of North Rollins Street adjacent to and west of the west line of Lots 9 through 16 of Block 3 of the Original Town, now City of Centralia, Missouri; and

WHEREAS, a public notice was published in the November 9, 2011 issue of the Centralia Fireside Guard, a newspaper of general circulation in Centralia, Missouri, stating that a public hearing concerning said proposed street right-of-way vacation would be held before the Centralia Board of Aldermen on Monday, November 21, 2011, at 7:00 p.m. in the Council Chambers of the Centralia City Hall; and

WHEREAS, No citizens or parties in interest appeared at the hearing, and there were no written comments supporting the proposed vacation and there were no written comments opposing the proposed vacation; and

WHEREAS the Board of Aldermen of the City of Centralia, Missouri, deems it necessary, expedient and not detrimental to the interests of the City of Centralia, Missouri, to close, discontinue and vacate that portion of the street right-of-way of North Rollins Street adjacent to the west line of Block 3 of the Original Town, now City of Centralia, Missouri, more fully described below.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CENTRALIA, MISSOURI, as follows:

SECTION 1. There is hereby VACATED, CLOSED and DISCONTINUED as a public street in the City of Centralia, Missouri, the portion of a public street in the City of Centralia, Missouri, more fully described as follows:

The East twenty feet of the street right-of-way of North Rollins Street adjacent to and west of the west line of Lots 9 though 16 of Block Three (3) of the Original Town, now City of Centralia, Missouri.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall take effect and be in full force and effect from and after the date of its passage and approval.
