Chairperson Aleshire opened the public hearing at 6:03 p.m. Bormann spoke to the fact that he had prepared the revised preliminary plat for Barela's Subdivision. Hearing no further comments, the public hearing closed at 6:04 p.m.

5. COMMISSION RECOMMENDATION

a. Barela Subdivision Preliminary Plat

Minutes:

The Commission members discussed the history of the Barela Subdivision plat and documents regarding the 2005 approval of the plat were provided in the meeting packet. There was some discussion regarding items that were changed on the plat from the original version in 2005, including a 40' right-of-way along the east side of the property that is adjacent to Jefferson Street instead of the former 25' right-of-way, as well as the request to approve the 36' radius paved portion of the cul-de-sac that was originally approved in the plat of 2005 and is already constructed. Behrns made a motion to approve the Barela Subdivision preliminary plat with the following conditions for the developer: 1. Repair a broken section of the curb that is about 4' . 2. Clean the drainage easement between lots 3 & 4 that has become clogged. 3. Install sidewalks along Barela Circle, including on the lot adjacent to lot 1. 4. Enter into an agreement with the City to ensure that money is put into escrow by the developer for the future installation of sidewalks, curb, and gutter along the north side of Wigham Street. Hughes seconded the motion, and the motion passed by unanimous voice vote.
