1.	In consideration for funding by CITY as set forth below, OWNER agrees, at OWNER'S sole cost								cost:

completion shall include obtaining and satisfying the requirements of a demolition permit (including City approved capping of the existing sewer line). The CITY may accept the application for a building permit and commencement of construction as completion of the demolition instead grading and seeding of the property with grass.

- b) OWNER shall obtain a demolition permit from CITY for the demolition work set forth above before beginning any of the demolition work.
- c) OWNER shall obtain a building permit from the CITY for the construction work set forth above before beginning any of the construction work. Either no later than sixty (60) days after full completion of construction; OR no later than the deadline of \_\_\_\_\_\_\_, OWNER shall provide documentation either of expenses or an independent appraisal of the value of the single-family house, duplex, or commercial building to be used for the conduction of business constructed on the property described above.
- 2. In consideration for OWNER'S specified actions set forth above, CITY agrees to pay OWNER One Thousand Five Hundred Dollars (\$1,500.00) at the successful completion of the demolition as described above in Section 1a. and CITY agrees to pay OWNER One Thousand Five Hundred Dollars (\$1,500.00) at the successful completion of construction as described above in section 1c.; OR the CITY shall make only one full payment of Three Thousand (\$3,000.00) Dollars to the OWNER after the successful completion at the successful completion of construction as described above in section 1c. Prior to payment to the OWNER by the CITY of any reimbursement, the OWNER shall document paid expenses for demolition in excess of One Thousand Five Hundred Dollars (\$1,500.00) at the successful completion of the demolition and documentation of expenses in excess of One Thousand Five Hundred Dollars (\$1,500.00) at the successful completion of construction or proof an assessed value in excess of Eighty Thousand Dollars (\$80,000) for the newly constructed single-family home, duplex, or commercial building to be used for the conduction of business on the previously blighted property,
- 3. This Contract shall be binding upon the parties and their heirs, legal representatives, personal representatives, successors, and assigns.
